6. The Grantee agrees to pay all related service fees involved in making the material available. Grantor agrees to declare these fees prior to release of footage.

7. The Grantee agrees to include the screen credit: **Alaska Film Archives - University of Alaska Fairbanks.**

8. The Grantee agrees to provide the Grantor with the URL link and/or (1) unaltered DVD or distribution copy in any form of the completed production.

9. The Grantee grants the University of Alaska rights to publicly show the finished production in classes and/or auditoriums where no admission fee is charged and circulate physical DVD or provided distribution copies through the University of Alaska library system.

Any waiver is entirely at the discretion of and must be approved in writing by the head of the Alaska and Polar Regions Collections & Archives Department. One hundred percent of this additional fee will go toward support of the Bradford & Barbara Washburn Research Fund at UAF.

Signed Moving Image Usage Agreement is required prior to release of clips for any production use. Prepayment is required for use requests totaling greater than 3 minutes (180 seconds) of footage; this fee is non-refundable. Each rate level covers all uses listed below it as well; for example, Nation/World Broadcast use fees also cover fees for Webcast and DVD copies, etc. **WE WILL NOT SIGN ALTERED AGREEMENTS OR OUTSIDE LICENSING AGREEMENTS OF ANY KIND**
